ARRANGEMENT OF REGULATIONS

REGULATION

1. Citation
2. Designation of places of entry and exit
3. Conditions

IN EXERCISE of the powers conferred on the Minister of Finance by section 53 of the Customs Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Customs (Designation of Places of Entry and Exit) Regulations, 2022. Citation

2. The Nedbank Tour de Tuli cyclists and volunteers shall enter and exit Botswana at the following ungazetted points with effect from 21st July, 2022 to 31st July, 2022 — Designation of places of entry and exit

<i>Ungazetted Point</i>	<i>Hours of Operation</i>	<i>Point of Entry</i>
S.22.10427* E29.27445*	0600 hours – 1800 hours	Botswana from Zimbabwe
S.22.19167* E29.35322*	0600 hours – 1800 hours	Botswana into South Africa
S.22.19578* E29.36836*	0600 hours – 1800 hours	Botswana into South Africa.

- 3.** Entry at the ungazetted points is subject to the following conditions — Conditions
- (a) the cyclists and the volunteers shall fully comply with immigration facilities; and
 - (b) the cyclists and the volunteers shall not export any goods through the ungazetted points.
